Under his guidance, Blair boasts an impressive record of 488-163, including 17 MAPL titles and 21 NJ prep "A" state finals appearances, with five state championships and one open title. Nine alumni have played in the NCAA Final Four, three have won NCAA D1 National Championships, and over 80 players have ended up on Division I rosters. Ten former players have played professionally overseas, and some are now coaching at the NBA, NCAA, and prep school levels. Before joining Blair, Coach Mantegna served as an assistant coach at four colleges for eight years, including three years each at Boston University and Lehigh University. He has also had success in international competitions, helping South Sudan's men's national team win three games at the 2023 FIBA World Cup and qualifying them for the 2024 Paris Olympics.
