If you are at least 16 but less than 18, you can be issued a graduated driver license (Class G). At the age of 18, you become eligible for a Class D driver's license. Individuals under 18 can opt for the Permit Test @ Home Program. With this option, you can take the DMV written test online under the supervision of a parent or legal guardian. After passing the test, schedule an appointment at an Arizona MVD office to obtain your permit. If you are 18 years old or older, you can take the exam at a driver license office or at an authorized third-party provider. To take the DMV test in Arizona, you must bring to an MVD office: A completed application One primary document (U.S. passport, certified copy of a birth certificate, ...) Two proofs of residency (documents with your name and address from a business, organization, or government agency) Proof of your Social Security Number If your name is different, show legal proof of the name change. The DMV written test for the driver's license in Arizona is available in several languages, including: English, German, Vietnamese, Mandarin, Spanish, Arabic, Russian, Italian, French, Tagalog, Korean. A verbal test is offered if you have difficulty reading, made many mistakes on a previous test, or the exam isn't available in your language. To schedule a verbal test, check the nearest MVD office and make an appointment. To get ready for the Arizona DMV written test, start by reading the Arizona Driver's Manual. This manual has all the info you need to study for the exam: traffic signs, road rules, and safe driving practices. For the initial 6 months, drivers holding a graduated driver license in Arizona face specific restrictions: They cannot drive between midnight and 5:00 a.m. unless accompanied by a parent or guardian with a valid license. Driving alone is permitted when traveling to or from sanctioned school activities, places of employment, religious events, or during a family emergency. They cannot transport more than one passenger under 18, except for siblings or when accompanied by a parent or legal guardian in the front passenger seat. The Arizona instruction permit is valid for a duration of 12 months. Use this time to complete an Arizona MVD-approved driver education program, and after holding the permit for a minimum of 6 months, you can apply for a graduated license. If you fail the DMV written test on your first attempt, you can return to an MVD office or an MVD Authorized Third Party office the next business day to retake the test. If you fail the exam three times, you have to pay another application fee to take it again. The Arizona CDL knowledge test assesses your understanding of commercial driving regulations. You must pass this test to obtain a Commercial Learner's Permit (CLP), which is required before taking the skills test for a full CDL. The test covers vehicle operation, safety regulations, traffic laws, and safe operating procedures. It's administered electronically at MVD offices throughout Arizona and includes both federal standards and Arizona-specific rules to ensure you're prepared to operate commercial motor vehicles in Arizona and across state lines. There are no exceptions to this language requirement for CDL testing in Arizona. No. You cannot use any aids during your test. Study materials, electronic devices, reference materials, and calculators are all prohibited during testing. Testing areas are monitored, and using prohibited materials will result in test failure. All personal items must be stored in a designated area during testing, including: Cell phones and electronic devices Notes or cheat sheets CDL manuals Reference materials of any kind Calculators (unless specifically authorized for certain questions) Using prohibited materials during testing could result in immediate disqualification and may affect your ability to retest in the future. There is no time limit to complete your test. Most applicants finish the general knowledge test in 60-90 minutes and endorsement tests in 30-45 minutes each. If taking multiple tests in one visit, plan accordingly. The MVD provides sufficient time to complete the tests without rushing. If you have documented learning disabilities or other special needs, accommodations may be available with proper documentation - request these in advance.
