It must begin with the following wording: "I (name) do solemnly and sincerely declare..." And end with the following statement: "and I make this solemn declaration conscientiously believing the same to be true, and by virtue of the provisions of the Statutory Declarations Act 1835." Statutory declarations are commonly used by declarations signed by a solicitor or Commissioner for Oaths, for use in the UK, prescribed rates apply, whilst for those requiring to be notarised for use abroad, regular notarial fees will apply. The person who witnesses the statutory declaration will need to sign and either write or stamp their name, address, and capacity. However, you should be mindful that whoever is asking you to provide the statutory declaration may impose their own limit on how long it can last.
